- Protection of first-aiders : First Aid responders should pay attention to self-protection and use the recommended protective clothing

5.2 Special hazards arising from the substance or mixture

- Specific hazards during fire-fighting : Risk of explosion if heated under confinement.

- Advice on safe handling : Open drum carefully as content may be under pressure. Protect from contamination. Do not swallow. Do not breathe vapours/dust. Avoid exposure - obtain special instructions before use. Avoid contact with skin and eyes. Avoid formation of aerosol. Take precautionary measures against static discharges.
