



Self-Declaration form to enter United Initiators GmbH Pullach

Coronavirus (COVID-19/ SARS-CoV-2): Mandatory self-declaration form for **employees of partner companies, external employees, and visitors** before entering the facility.

In accordance with United Initiators GmbH's regulations, which are based on the recommendations of the Bavarian State Office for Health and Food Safety, each visitor must complete this form before entering the plant:
